LAW

ON SEATS AND TERRITORIAL JURISDICTION OF COURTS AND PUBLIC PROSECUTOR'S OFFICES

I. SCOPE OF THE LAW

Article 1

This Law shall establish misdemeanour, basic, higher, commercial and appellate courts, identify the seats and territorial jurisdictions thereof, and designate units of the Appellate Misdemeanour Court and the Administrative Court respectively, and territorial jurisdictions thereof.

This Law shall also establish basic, higher and appellate prosecutor's offices and the seats and territorial jurisdictions thereof.

The Higher Court in Belgrade shall have jurisdiction to decide in the first-instance about prohibition to be engaged in distribution of printed media and dissemination of information through mass media and to try in disputes on publishing of correction of an information or respond to information due to violation of prohibition of the hate speech; protection of the right to private life; or the right on personal record; omission to publish information and compensation of damage related to publishing of information for the territory of the Republic of Serbia.

The Higher Court in Belgrade shall also have jurisdiction for disputes on copyrights and similar rights, protection and use of inventions, industrial design, models, brands and markings of geographical origin, integrated circle topography, i.e., topography of semi-conduct products and rights of breeders of plant varieties for the territory of the Republic of Serbia.

IV. COURTS AND PUBLIC PROSECUTOR'S OFFICES IN THE AUTONOMOUS PROVINCE OF KOSOVO AND METOHIJA

Article 12

Establishment of courts and public prosecutor's offices with jurisdiction for the territory of Kosovo and Metohija, their units and territorial jurisdictions shall be regulated by *lex specialis*.

V. TRANSITIONAL AND FINAL PROVISIONS

Article 13

Courts and Public Prosecutor's Offices, established by the Law on the Seats and Territorial Jurisdictions of Courts and Public Prosecutor's Offices, ("Official Gazette of the Republic of Serbia", No. 116/08) shall continue their operations until the day this Law begins to be implemented .

The cases, in relation to which no judgment is rendered by the courts and public prosecutor's offices established by the Law on the Seats and Territorial Jurisdictions of Courts and Public Prosecutor's Offices ("Official Gazette of the Republic of Serbia", No. 116/08) by the date this Law begins to be imlemented, shall be assumed by the courts and public prosecutor's offices with subject matter and territorial jurisdiction, established hereof.

Notwithstanding paragraph 2 herein, the cases filed before the appellate courts by the date this Law begins to be implemented, shall be decided by the appellate courts with jurisdiction in accordance with the Law on the Seats and Territorial Jurisdictions of Courts and Public Prosecutor's Offices ("Official Gazette of the Republic of Serbia", No. 116/08).

The intake offices in the court units of the basic courts set by the Law on the Seats and Territorial Jurisdiction of Courts and Public Prosecutor's Offices ("Official Gazette of the Republic of Serbia", No. 116/08), which in accordance with the provisions herein shall cease to operate, shall keep on working on the intake and certification of documents and signatures.

The work related to the intake offices referred to in paragraph 4 herein shall continue until the public notaries start operating.

Article 14

By the date this Law begins to be implemented the High Judicial Council shall in accordance with the provisions of the Law on Judges, transfer judges and lay judges to the courts established herein, which were not established by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08).

By the date this Law begins to be implemented, the High Judicial Council shall in accordance with the provisions of the Law on Judges, transfer judges and lay judges to the courts established herein, which territorial jurisdictions as compared to the territorial jurisdiction set by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08) have been changed.

By the date this Law begins to be implemented, the High Judicial Council shall appoint acting presidents of the courts established herein, which were not

established by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08).

By the date this Law begins to be implemented, the High Judicial Council shall appoint acting presidents of the courts which territorial jurisdictions as compared to the territorial jurisdiction set by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08) have been changed, except for the courts where the presidents have been appointed in accordance with the Law on Judges.

On the date this Law begins to be implemented, the offices of the acting presidents of the courts established herein which territorial jurisdiction as compared to territorial jurisdiction set by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08) have been changed, shall terminate.

Discharging the office of court president referred to in paragraphs 3 and 4 herein shall last until the appointment of court presidents in accordance with the Law on Judges.

Article 15

By the date this Law begins to be implemented, transfer of deputy public prosecutors from the public prosecutor's offices that ceased to operate shall be carried out in accordance with the Law on Public Prosecutor's Office.

By the date this Law begins to be implemented, acting public prosecutors in the public prosecutor's offices established herein, which were not established by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08) shall be appointed in accordance with the Law on Public Prosecutor's Office.

By the date this Law begins to be implemented, acting public prosecutors shall be appointed in the public prosecutor's offices established herein which shall undertake jurisdiction of the public prosecutor's offices that ceased to operate in accordance with the Law on Public Prosecutor's Office.

Public Prosecutors whose offices terminated due to cessation of operations of the public prosecutor's offices shall continue to discharge deputy public prosecutor offices in accordance with the Law on Public Prosecutor's Office.

Discharge of the public prosecutor's office referred to in paragraphs 2 and 3 herein shall last until the appointment of public prosecutors in accordance with the Law on Public Prosecutor's Office.

Article16

Courts and public prosecutor's offices established herein shall take over all necessary funds for their work, equipment, archive and staff from the courts and public prosecutor's offices established by the Law on the Seats and Territorial Jurisdictions of Courts and Seats ("Official Gazette of the RS", No. 116/08).

The Minister competent for the judiciary shall establish a commission which shall, until the day of the implementation hereof, be in charge of the distribution of tools, equipment and archives referred to in paragraph 1 herein.

The High Judicial Council and the State Prosecutorial Council shall establish commissions to pass decisions on assigning the court and public prosecutor's office staff referred to in paragraph 1 hereof, in accordance with the interim act on the internal organization and job classification to be issued by the Minister competent for the judiciary by December 1, 2013.

Article 17

By the date of the adoption of *lex specialis* referred to in Article 12 herein, the courts and public prosecutor's offices referred to in Article 2 item 13, Article 3 item 11, Article 4 item 7, Article 9 item 11 and Article 10 item 7 of the Law on the Seats and Territorial Jurisdiction of Courts and Public Prosecutor's Offices ("Official Gazette of the RS", No. 116/08) shall continue their operations.

By the date of the adoption of *lex specialis* referred to in Article 12 herein, the courts and public prosecutor's offices referred to in Article 5 item 8, Article 6 item 3, Article 7 item 2, Article 8 item 2 and Article 11 item 3 herein shall continue to fulfil their statutory jurisdiction for the territory of the Autonomous Province of Kosovo and Metohija.

Lex specialis referred to in Article 12 herein shall be enacted by December 31, 2013.

Article 18

The Law on the Seats and Territorial Jurisdictions of Courts and Public Prosecutor's Offices ("Official Gazette of the Republic of Serbia", No. 116/08) shall cease to apply as of the day this Law begins to apply, except for the provisions of that Law referred to in Article 17, paragraph 1 herein.

Article 19

This Law shall enter into force on the day of its publication in the "Official Gazette of the Republic of Serbia" and shall be applied as of January 1, 2014.
