### THE LAW ON AMENDMENTS TO THE LABOR LAW

#### Article 1.

In the Labor Law ("Official Gazette of the Federation of Bosnia and Herzegovina", no. 26/16 and 89/18), in Article 114, paragraph (1), the words: "must" are replaced by the word "can".  
In paragraph (3), the words: "except in the case of termination of the employment contract in accordance with this law.", are replaced by the words: "except in the case of the worker's request for compensation for damages or other monetary claim from the employment relationship".

#### Article 2.

This law enters into force on the following day from the day of its publication in the "Official Gazette of the Federation of Bosnia and Herzegovina".
