# **Bill**

An Act to amend the Constitution.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 29 of the Constitution:

**Be it therefore enacted by the Oireachtas as follows:**

**Amendment of Article 29 of the Constitution**

10

1. Article 29 of the Constitution is hereby amended as follows:

- (a) the subsection, the text of which is set out in *Part 1* of the *Schedule*, shall be inserted after subsection 10° of section 4 of the Irish text;
- (b) the subsection, the text of which is set out in *Part 2* of the *Schedule*, shall be inserted after subsection 10° of section 4 of the English text.

**Citation**

- 2. (1) The amendment of the Constitution effected by this Act shall be called the Forty-first Amendment of the Constitution.
- (2) This Act may be cited as the Forty-first Amendment of the Constitution (Agreement on a Unified Patent Court) Act 2024.
